

## 7 Point Briefing – Community Partnership Intelligence Form



The Hull Collaborative Partnership encourages all partners to play an active role in community safety by sharing intelligence through the Community Partnership Intelligence (CPI) Form.

This form helps the police build a clearer picture of local issues, enabling early intervention and prevention. This briefing explains what the CPI Form is, why it matters, and how you can use it effectively.



### What is the CPI Form?

The CPI Form is a secure tool for professionals and partner agencies to share **non-urgent** information with the police.

It is not for reporting crimes or safeguarding concerns. Instead, it helps build intelligence that supports proactive policing.

Partners submitting intelligence that involves child criminal or sexual exploitation, adult exploitation, human trafficking, modern slavery, organised immigration crime to use the words '**OP NOTIFY**' within the body of the intelligence. Use the words '**OP BOMBARDIER**' for any intelligence surrounding home invasion or cuckooing.

### Purpose of the CPI Form

The form enables the police to:

- Identify patterns or links in community issues.
- Fill intelligence gaps and identify future development opportunities
- Inform operational decisions to reduce threat, harm, and risk.

### What Information Can Be Shared

Examples include:

- Anti-social behaviour.
- Drug-related harm or county lines activity.
  - Exploitation (child or adult).
    - Modern slavery.
    - Community tensions.
- Suspicious activity, vehicles, or locations.

**Important: Do not include crimes or immediate safeguarding concerns.**

### Who Can Submit?

- Any professional or partner agency with relevant non-urgent information that could support policing efforts.

Members of the public need to report information via Crimestoppers or via the Humberside Police website.

### How to Submit

Complete the form online (average time: 10 minutes):

Provide details about:

- You and your organisation.
- The source of the information.
- Who/what the information concerns.
- Any supporting documents or images.

### Important Considerations

- Do not use the CPI Form for emergencies—call 999.
    - For crimes, use 101 or online crime reporting.
  - For safeguarding concerns, follow your local Multi-Agency Safeguarding Hub (MASH) referral process.
    - Always use the latest version of the form from the official site.
- Do not include unnecessary personal details—share only what is relevant.**

### How Is the Information Used?

Once submitted:

- Police intelligence handlers assess the information.
- Information may be generated into intelligence and recorded on police systems for officer awareness, development and/or further tasking.
- In some cases, no further action may be taken if it is assessed that the Police have no policing purpose to retain the information.
- Crimes and Safeguarding concerns should not be reported via the CPI form. If the Police identify a crime or safeguarding concern that is not obvious from the outset then this will be re-directed accordingly.
