# Contextual Safeguarding Conference 23<sup>rd</sup> March 2023

#### Introduction

The Hull Safeguarding Children Partnership (HSCP) had the privilege to co-host the Contextual Safeguarding Conference on the 21<sup>st</sup> of March 2023, alongside The East Riding Safeguarding Children Partnership and the Office of Police and Crime Commissioner. The purpose of the conference was to reflect on our approach to tackling child exploitation.

Contextual safeguarding continues to be a priority for the HSCP to identify and reduce the number of children affected by exploitation. The focus is to ensure that there is a good understanding across the partnership of the complex and interrelated risks associated with child exploitation to enable support and intervention to take place at the earliest opportunity to reduce this.

The conference was a large-scale event held at the MKM stadium, with over 300 attendees. The conference provided opportunities to network across Hull and East Riding with colleagues across the partnership including Humberside Police, Health, Education providers, Local Authority, Probation services, and the Voluntary and Community sector.



#### Keynote Speakers

Kay Durrant, Independent Chair for Hull, and East Riding safeguarding Children Partnership provided an overview of governance structures across the partnership. DSI Philip Booker delivered a presentation on local policing strategies, an introduction on the vulnerability tracker and a summary of the important work of Pitstop and multiagency working. There was a focus on children's vulnerabilities outside the family home and working in partnership with agencies to identify children at the earliest opportunity.





The Police and Crime Commissioner, Jonathan Evison, shared the Not in Our Community resources which can be utilised and used to work with young people to raise awareness of child exploitation.

The keynote speakers where influential in their delivery, Dr Kate Richardson (OBE) spoke about the important work of the National Crime Agency and how they are responding to contextual safeguarding from a national perspective.



"Missed opportunities to protect young people often increase the risks they face."





## Attendees by Organisation



#### "More time for workshops to network and work through learning"


"Consider staff availability for full day events as many are part time and on face-to-face delivery. Consider half day events to offer greater opportunity for breadth of workforce."






#### **Usefulness for Practice**
