





Child Death Review JOINT AGENCY RESPONSE Training for professionals working in Hull and East Riding of Yorkshire

Every parent has the right to have their child's death investigated properly. Fortunately, unexpected childhood deaths are rare, but as a professional caring for children you might be involved in the immediate medical or investigative response to a death, or be required to provide information about your involvement with the child and family and/or provide help and support to a family.

Working Together 2023 (chapter 6, p145) and Child Death Review statutory guidance describes the statutory process for reviewing child deaths, including the circumstances of death requiring a multi-agency response – a thorough and systematic way that is sensitive to and supportive of parents. A Joint Agency Response can also be initiated at the point of presentation if a child is brought into hospital, and although successfully resuscitated, is expected to die.

- Explain to families the purpose and process of the Joint Agency Response and support them in the context of the wider purpose of the child death review process to learn lessons to help prevent future deaths;
- Collate and evaluate information from the investigation in the light of knowledge of nature and causes of unexpected child deaths;
- Recognise and respond appropriately where there are suspicious circumstances surrounding the death of a child.
